Approval of October 7, 2019 Minutes:

Board Notes:

- 1. Meeting started at 6:00pm in closed session to discuss a matter regarding ratings and inappropriate communications. Returned at 6:11pm to open session.
- 2. John motioned to approve minutes for August 28. Seconded by Fred.
- 3. Budget discussion: John motioned, seconded by George to approve \$500 each for three IC chairs. Further discussion to develop fund raising ways to increase the IC compensations, i.e., paid observations of scrimmage games, 50/50 raffles. Looking for other ideas.
- 4. Discussed incentives for members to join early.
- 5. Determined Dec. 31 will be last day for non-penalty registration. Afterwards, (Jan. 1, 2020) dues increase \$25.
- 6. Classroom instructional meetings will last 2.5 hours. (6:30-9:00pm).
- 7. Mike and Scott updated their progress on the Constitution and Bylaws. Hope to have a proposal by December 2 meeting.
- 8. Ratings committee will be open to all board members and or willing volunteers to commit to participating in the process.
- 9. Discussed the "gaps" perceived by the board in the rating's process, and areas to improve upon in the rating format, such as a standardized rubric, eliminating the use of "numbers" when rating, and incorporating a "narrative" approach vs a numbered approach.
- 10. Discussed the definition of an "Associate Member," including concerns with NASO ins, commitment to SB Unit, CIF playoff contests not going beyond one-round, regular season games okay to work, whether or not to attend SB classes, clinics, and providing proof of class-time with other Units, and whether or not a member-in-good-standing in the Associate unit. Also, Associate member, if selected to playoffs, must attend our playoff meeting. The updated CBL will reflect changes.
- 11. It was determined the Finals list discussion will occur in November and perhaps in February, March, and April based on concurrent obs.
- 12. Director's reports tabled to November 4 meeting.

1. John motioned, seconded by Fred to approve Associate mbrs must attend a minimum of one SB Unit meeting per year to be accepted as a member AND pay full-dues. Passed 5-0.
