Approval of November 4, 2019 Minutes: Board Notes:

- 1. Mike reported no budget update other than seven (7) more unit members paid dues.
- 2. Meeting dates will be posted soon on the <u>www.cbuasbay.org</u> website.
- 3. The 2020 playoff mtg date will TBD next board mtg. The playoff meeting will be at the Haw. Mem. Ctr. at 7PM. Jerry will secure room.
- 4. Instructional credit agenda item pushed to Dec. 2 mtg.
- 5. MLB umpire (unit graduate) Malachi will attend the Dec 9 mtg to promote his clinic.
